Digital Learning Plans

(COM-21-073)

The State Board of Education has approved a streamlined Act 1240 waiver process for the 2021-2022 school year for districts that wish to offer a digital learning option. This will be different from last fall's process, as each district that chooses to continue a digital learning instructional option for students will need to complete an application and submit it to DESE. To ensure that the district participates in the expedited process, applications should be submitted by May 1, 2021. The applications will be reviewed by DESE staff and submitted to the State Board with recommendations for approval if the plan meets requirements that include involvement of staff in the application development and approval of the local school board. The online application can be accessed on the <u>Digital Learning webpage</u>.

Crowley's Ridge ESC is offering a virtual Professional Development (Session 436157) on Tuesday, February 16th from 9:00-12:00. Dawn Bessee, Teacher Center Coordinator, and Sherry Kennedy, Team Digital Specialist, will use that time to provide an overview of the Guidebook for Digital Learning and facilitate discussions regarding districts' best options for their plans.

There will be two follow-up sessions and work time on March 3rd (an a.m. session and a p.m. session). On March 31st and April 14th, CRESC will facilitate peer-review sessions for any districts who are interested in having their digital learning plan reviewed and given feedback prior to sub mitting it to DESE for review (NOTE—DESE does not approve the plans; they review the plans before sending them to the State Board of Education for approval).

*This process and application is not for schools that wish to create (or already have) a <u>district conversion charter school</u> with a separate LEA.

Districts that wish to submit an **AMI application** for the 2021-2022 school year must use the AMI component of the online application found on the Digital Learning webpage.



ACT

The regional ACT Collaborative Team held its first meeting to begin the discussions concerning current ACT data and how stakeholders can support students moving forward. The team consists of area high school counselors, district personnel, Education Cooperative Teacher Center Coordinators, our ERZ (Jill Clogston), DESE personnel, and representatives from our higher education institutes. The next meeting has been scheduled for **March 4**th.

ACT has gone green. The ACT Success Portal (https://success.act.org/s/) will be used to enter accommodations and view reports. Testing Accommodations and Accessibility (TAA) must be accessed through this portal. A user must have the "Trusted Agent" role in order to access the platform. Mathematics

Tier I Math Curriculum Grants have been awarded to approximately 38 districts across the state. Our math specialists will be available to support awarded schools in our region as they utilize this grant to implement high-quality, rigorous math curriculum.

MathQuest will be offered to Arkansas K-12 math teachers, coaches, IF's beginning in the summer of 2021. The 2 year long professional development consists of 2 days during the summer, 2 days in the fall, 2 days during the spring each year. The group of teachers that started the 2 year process in the summer of 2019 will continue into year 2 beginning in the summer of 2021. A new cohort will start with year 1 during the summer of 2021. There will be a limited number of slots available. This training requires a signed MOU by your Superintendent. Interested teachers should contact their CRESC Math Specialist.

FEBRUARY IS NATIONAL CAREER AND TECHNICAL EDUCATION MONTH®

Career and Technical Education (CTE) helps students acquire skills needed to begin the path to their occupational goals through occupational program areas. These occupational program areas are Agriculture Science and Technology; Business and Marketing Technology; Family and Consumer Sciences; Science, Technology, Engineering, Mathematics (STEM); and Trade and Industry. Upon completion of the program area courses, students will possess marketable job skills as well as college and career readiness skills needed to be successful in their chosen career path.

Each occupational program area has an accompanying Career and Technical Student Organization (CTSO). According to the National Coordinating Council for Career and Technical Student Organizations (NCC-CTSO), CTSOs "enhance student learning through contextual instruction, leadership, and personal development, applied learning and real-world application." Students who are members of a CTSO have the opportunity to further develop the skills necessary to be successful in his or her chosen career path through CTSO activities, programs, and competitive events. Students also have the opportunity to hold leadership positions at the local, state, and national level and attend development conferences to network with other students and business/industry partners.

Jonesboro Mayor, Harold Copenhaver, recently met with FCCLA members from Valley View High School and subsequently signed a proclamation that designates February 8-12, 2021 as national FFCLA week in Jonesboro.

In an effort to assist teachers in developing meaningful, compliant transition plans, Arkansas Transition Services has developed a series of short (15 to 20 minutes) video modules on transition assessments. These are free to all districts state-wide and are easy to access on our website. Also, ATS offers assistance in examining a district's special education transition program through the use of the Predictor Implementation School/District Self-Assessment (PISA). The PISA tool helps districts identify the degree to which they are implementing evidence and research based practices that are likely to produce positive post-school outcomes. The results are then used to formulate an action plan to improve and implement those practices.
